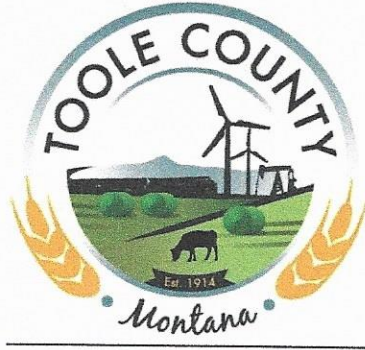

This meeting in accordance with Montana law is being video recorded.

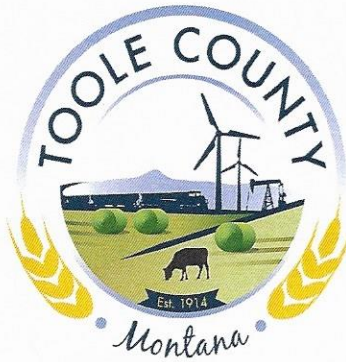
Public comment is allowed on all agenda items at the direction of the Chairman and following Board rules.

RESOLUTION 8-2025
A RESOLUTION AMENDING BUDGETS

WHEREAS, the Board of Toole County Commissioners may amend the county budget during the fiscal year per MCA 7-6-4006. A Public Hearing was conducted during a scheduled meeting. Budget amendments providing for additional appropriations must identify the cash available, unanticipated revenues, or a previously unbudgeted revenue that will fund the appropriations,

WHEREAS, The Board of Toole County Commissioners have adjusted various fund to show the amendments,

THEREFORE, TO BE RESOLVED, the following unanticipated amendments were made for the 2024-2025 budget year:

An audit adjustment to Fund 2900-440200-350 to account for the payment to Logan Health. This decreased the Current Appropriations. This adjustment did not change the overall budget.

An adjustment to Fund 2863 decreasing the repair & maintenance code-360 to increase personal services code-100 by \$542.94. This adjustment did not change the overall budget.

An adjustment to Fund 2866 decreasing the repair & maintenance code-360 to increase personal services code-100 by \$773.85. This adjustment did not change the overall budget.

An adjustment to Fund 2977 decreasing operating supplies code-220 to increase personal services code-100 by \$12,000. This adjustment did not change the overall budget.
