## RESOLUTION 9-2024

A RESOLUTION TO ESTABLISH A PETITION FOR INSTALLATION/REMOVAL OF A CATTLE GUARD ON A TOOLE COUNTY ROAD.

Whereas: All cattle guards currently placed on designated Toole County Roads are the property of the County and are the responsibility of the County to maintain and replace as needed, and

Whereas: Landowners often request the County to install or remove cattle guards on County Roads for various reasons, and

Whereas: Currently Toole County does not have a policy or procedure process in place to accept these requests, so a Petition has been created for this purpose, and

Whereas: An owner may petition the Board of County Commissioners for the Installation of Cattle Guards on a designated County Road by submitting the newly created Petition for Installation/Removal of a Cattle Guard (available at the Road Department or the County Website), and

Whereas: Upon approval of the Petition, the Road Department will install a cattle guard pursuant to the Petition based on the County Road Department's schedule, and

Whereas: After installation of the cattle guard, the Toole County Road Department shall issue an invoice to the Petitioner for costs associated with the cattle guard only, and Whereas: Once the cattle guard is installed, it will become Toole County property to maintain and replace as necessary, and

Whereas: For a Petition to remove a cattle guard on a designated County Road, and upon approval of the newly created Petition, the Road Department will remove the cattle guard subject to the Petition, and once removed, the cattle guard will remain the property of Toole County, and

NOW THEREFORE BE IT RESOLVED: The newly created Petition for Installation or Removal of a Cattleguard on a County Road will become effective on the date the Toole County Commissioners approves this Resolution.
