PRESENT: **Terry Tomsheck, Mary Ann Harwood and Terry Kimmet**

PLEDGE OF ALLEGIANCE

Approval of February 5, 2026, Meeting Minutes: Mary Ann made the motion to approve the minutes, seconded by Terry Kimmet, and motion passed.

1. Consider re-appointment of Gwen Heaton to the Board of Health, as recommended by the board, for term to expire 12/31/2028. **Terry Kimmet made the motion to approve. Mary Ann seconded it. Motion carried.**
2. Consider re-appointment of Ben McCann to the Galata Water District Board as recommended by the board, for term to expire 05/31/2030. **Terry Kimmet made the motion to approve. Mary Ann seconded it. Motion carried. This is for the Toole County Representative.**
3. Consider re-appointment of Terry Tomsheck to the Northern Transit Interlocal board with a term ending 12/31/2029 and designating Mary Ann Harwood and Terry Kimmet as voting member alternates. **Mary Ann made the motion to approve, seconded by Terry Kimmet, and motion passed. This was already approved in the January 5th meeting minutes.**
4. Consider the Joint Powers Agreement Montana Association of Counties Property & Casualty Trust, after the bylaw changes. **Mary Ann made the motion to approve,**

seconded by Terry Kimmet, and motion passed. This amendment to the Bylaws was voted on and passed at the MACo Midwinter Convention in February.

- 5. Consider supporting Northern Transit Interlocal coordination plan for fiscal year 2027. Mary Ann made the motion to approve the plan. Terry Kimmet seconded the motion and motion carried. This is for the annual \$5,000 contribution to the NTL.**

- 6. Discussion and consideration of the new rates for the MACo Health Care Trust. Terry Kimmet made the motion to add the \$5,000 HD plan to the four existing plans as well. Mary Ann seconded the motion, and it carried. There was also discussion on the contribution rate of the County's for the Health plan since there was a 5% increase. Therefore, another motion was made by Terry Kimmet to raise the County contribution \$50.00 from \$1025 to \$1075 for Fiscal year 2027. Mary Ann seconded the motion. Passed.**
